## NLBID FACADE BEAUTIFICATION GRANT

The goal of the Northern Liberties Business Improvement District (NLBID)'s grant programs is to improve the front exterior of BID members' properties, making the area more attractive to residents, shoppers, and visitors.

The Façade Beautification Program provides grants, up to \$1,000 every five years, to ratepayers and businesses located within the NLBID and typically covers improvements such as painting, brick repair, windows, doors, signage, lighting, planters and other improvements to the public street-facing exterior of an existing building. The NLBID makes awards on a first come first served basis until we hit our yearly budgeted allotment.

## **Application Process**

- 1. Email <u>info@explorenorthernliberties.org</u> to find out if your property and project are eligible.
- 2. Meet with a representative from the NLBID to discuss your proposed improvements.
- 3. Complete the application (below) and submit the following items with your application:
  - a. Color photos of the existing conditions
  - b. Illustrations showing the proposed improvements
  - c. A budget and if applicable for larger projects, two professional contractor estimates
- 4. Applications will be reviewed by the NLBID usually in 2-3 weeks\*.
- Once approval is received, work may begin and should be completed within six months.
- 6. To receive reimbursement, submit:
  - a. Paid in full invoice, and proof of payment (canceled checks, credit card statement, etc.). Do NOT pay contractors in cash.
  - b. Color photographs of completed work.

\*NOTE: Applications must first be approved by NLBID before work begins. Any work started before approval by the NLBID will not be eligible for a matching grant or reimbursement.
